
## IT ARCHITECT AND CLERK OF THE WORKS SERVICES

## **The Approach**


The *Clerk of the Works* service provides detailed performance specifications, system configuration, data conversion, system and network integration, and implementation management similiar to a *Clerk of the Works* in construction projects.

In the context of a major technology implementation, the framework shown to the right is used as a guide to ensure all organizational processes, work/communication flows, data management and governance, as well as staffing requirements, are aligned with the new technology system. A mismatch in any one of these critical areas can severely limit the chances for a successful implementation and seamless transition.

The "Clerk of the Works" service is typically

paid for by the selected IT application vendor as an optional component of its IT implementation cost. However, selection and supervision is done by the learning organization. This approach aids in providing adequate checks and balances and fosters proactive teamwork. The following duties are performed within the context of the Analytical Framework:

- Reviews monthly project performance reports on the progress of work
- Monitors the quality and effectiveness of the implementation
- Facilitates regular project oversight review meetings
- Proactively performs risk mitigation activities
- Mediates disputes or issues
- Ensures compliance with all contract terms and conditions
